On 12/22 the SCC reopening task force met and the following short term decisions were made:

Meetings will continue to be either in person with access available by Zoom or by Zoom only. The decision can be made by the committee.

The January 2nd worship service will only be available via Zoom. This change is ONLY for January 2nd and was agreed to because of the significant gatherings that may occur during Christmas and the New Year celebrations.

The reopening task force group agreed to meet the first week in January to determine the future of in person worship in the Meeting House and events scheduled within our facilities.

There was interest in polling the congregation about continuing in person worship.

A comment was made during the meeting that we have been fortunate that no COVID outbreak has been caused by any of our events or worship services. It is much safer for a member of our congregation to attend worship at the Meeting House than it is for them to go grocery shopping or attend any public event. We want to maintain that level of safety and make reasonable improvements as we move forward.

# Governing Board Minutes

#### Present to Speak - none

**Consent Agenda** The following items were approved by the Governing Board as part of the Consent Agenda.

- That the Board approves the Minutes of the November 10, 2021 meeting of the Board.
- 2. That the Board approves the Minutes of the December 1, 2021 meeting of the Board.
- 3. That the Board acknowledges receipt of the October Treasurer's report.
- 4. That the Board acknowledges receipt of updates from the Lead Ministry Coordinators.
- 5. That the board approves the recommendations from the Memorial and Special Gifts Committee for the distribution of 2021 Memorial Gifts. The details of the gifts and their distribution have been reviewed and approved by the financial sub-committee of the governing board.
- 6. That the Board authorizes the Treasurer to transfer any unspent budgeted money from the Library account (530100) for 2020 to the Library Projects off-budget account (330000). Rationale: this has been standard practice since moving library funding that had been under the legacy Women's Fellowship budget to the SCC budget. Janet Atkins confirmed the Library Committee's desire to do so again this year.

7. At the request of the Congregational Life Ministry Team Leader, that \$500 be added to the 521100 Fellowship Hours & Lunches budget line. Rationale: We have been more active than originally planned! The 2020 original budget had \$1200, the 2021 budget had \$500. This brings it up to \$1000.

**Search Committee** – Cass provided a brief update to note that the SCC profile has been submitted to the Conference for posting. Members of the Governing Board expressed gratitude that the search committee had reached this milestone.

**Task Force for Resuming In-Person Gathering** – Paul noted that the Christmas bazaar went well. He also reminded everyone that it is required for all participants in the service to remain masked throughout the service to comply with a town ordinance.

Leadership Discernment Committee—Stacy reported on progress to fill slate for Leadership Discernment Committee. The open positions still being sought include: Treasurer, Clerk, one member of Leadership Discernment Committee, and a college and high school member of the Governing Board. Paul Schur requested that the Leadership Discernment Committee also work with Pastor Debbie to identify two additional Deacons to increase the number of active Deacons supporting the worship team.

**Highlights of Pastoral Report** – provided by Rev. Dr. Debbie Pallatto-Fontaine

It has been a very busy time with a flurry of activity since my last report!

- Pastoral support and care through weekly phone calls, cards sent, home visits, and funeral services.
- Monday devotions sent out November-December
- Supported several Funerals for both church members and non-members.
- Scheduled and led a Lead Ministry Coordinators' meeting December 16.
   Each leader shared updates as well as planning for events through the end of December.
- Planning a workshop for leaders in January on "Silos to Collaboration" to discuss effective ways to collaborate among teams and to increase our visibility in the church and in the community.
- Supporting meetings and activity of the Search Committee, Pastoral Relations, Governing Board,

#### Worship Team and Leadership Discernment Committee

- Our Christmas Eve service this year will be in person at 5:00 p.m. Two signs were ordered to publicize the event and an announcement will be included in the Chronicle.
- Holding a holiday brunch for staff and any church members who are able to attend on December 16 at noon in the PH Lounge
- Served as the welcome greeter during the Church Fair this past Saturday; several new people came who had not been here before.
- The Rev. Darrell Goodwin was our guest preacher this past Sunday. He
  and his partner stayed during fellowship time and talked with several
  church members. Rev. Goodwin did some shopping at the SERRV table
  and also purchased 75 Christmas cards designed by Patrick Barton for the
  Southern New England Conference staff and Board. Rev. Goodwin
  interviewed me last week and that segment is posted on the Conference
  and SCC websites.
- Lessons and Carols service is this Sunday 12/12 at 10 AM. Six liturgists will
  participate.

It was noted by a member of the Governing Board that Pastor Debbie has been very busy with many items and that this is appreciated.

**Minister's Discretionary Fund** – The minister's discretionary fund is running low. There was discussion about using the unspecified plate collection at the Christmas Eve Service to restore funding level. This will be in addition to the annual collection for the Christmas Fund for which envelopes will be available.

**MOTION**: Sue made a motion to apply unspecified plate collection from the Christmas Eve Service to the Minister's Discretionary Fund. This will be in addition to envelopes which will be used to collect donations for the Christmas Fund. Cass seconded. The motion passed unanimously.

**Personnel Forms** – Personnel subcommittee of the governing board has created draft personnel forms for future use. It was noted that Pastor Debbie is using different forms for this year's employee reviews. Governing Board members are asked to review these forms and provide feedback so that the personnel committee can finalize a form for future usage.

Chapel Heating and Cooling and Meeting House – From the Buildings and Grounds Committee - Nancy presented information and led a discussion of a proposal to install HVAC mini-split systems to provide heating and cooling to the Chapel (\$8,600) and Meeting House (\$55,200). This would not include the Parish House or the Education Building. There was quite a bit of discussion about this subject with some of the following points being made:

#### Chapel:

- It was noted that mini-splits provide both heat and AC and that heat is the priority, but that AC would also be helpful.
- Providing a climate-controlled environment could expand programming both for faith formation and other ministries.
- There is a pipe organ in the chapel. It might not respond well to being in a heated/air-conditioned environment, and is not a particularly valuable or historic instrument. Other options for musical instruments could be considered.
- There was some discussion about the location of the mini-split system and the organ pipes.

**MOTION**: Jane Ann made a motion which was seconded by Paul to have the Buildings and Grounds Committee of the Governing Board work with the previously established Chapel committee to determine the best way to add heat and air conditioning to the chapel while also considering the organ and/or other musical instruments. The motion passed unanimously.

#### Meeting House:

- Adding AC will create a drier environment for the organ in the summer which could be detrimental to the wood. Trisha will discuss with some organ maintenance experts and explore options for humidification.
- There were varying degrees of enthusiasm about adding air-conditioning to the Meeting House, and it was decided that additional feedback from the congregation should be obtained.
- The Buildings & Grounds Committee will figure out the best way to start this conversation, identify pros and cons, identify additional building usage opportunity if AC was installed, and possibly poll the congregation.

**Church Sign/Parking Signs** – Duffy reported that he would like to purchase signs to help people find parking and buildings. Duffy will work with the Buildings & Grounds Committee on creating a recommendation.

Rental of 4<sup>th</sup> Parking space – Ben (previous communications and digital ministry director) has requested to be able to rent a parking space for one semester – he will graduate in the spring with his Master's Degree. Duffy recommended assigning the space with the Restricted Parking sign. This spot is not used often, so there should be minimal disruption to congregational parking. The rental of this spot will have the same rules for use as the other spaces.

*Motion*: Sue made a motion to allow a fourth parking space for rent for one semester. Bruce and Malta seconded motion. Motion passed.

Curtains in the Meeting House (discussion of item in Worship team report) – The curtains on the first floor of the meeting house have been removed because they were damaged. There has been feedback that the curtains are missed and should be replaced. A small team will be formed to make a recommendation to the board. The Putnam Fund has funds that can be used for this purpose.

#### Review of tasks

- Gov. Bd. members to provide feedback on Personnel Forms to Sue, Malta and Elaine
- Chapel team is asked to provide a recommendation on the proposal to add a mini-split system to the chapel.
- Buildings & Grounds Committee of the governing board will work with Ellen (Communications) to survey the congregation about the possibility of adding mini-splits to the Meeting House and Chapel.
- Establish team to make a recommendation about curtains for Meeting House. Sue will work with the worship committee to identify a team.
- Finance team to create a To-Do List for Budget Planning that can be used in future years.
- Gov Brd members asked to review Policy Book and identify areas to work on in next year.
- Tech Team has made improvements to sound system during services if there are additional issues please provide feedback.
- Sue will invite Ellen to attend the beginning of the next Governing Board meeting.

#### Meeting was adjourned with closing prayer at 9:10 PM

#### **Summaries of Ministry Reports**

**Buildings & Grounds Reported the following updates on activity** – Duffy Brookes

- Eric's Tree Service has failed to complete removal of the stumps. We will need to secure another firm to do the work.
- An official inspection of our water heaters was completed with positive results
- A new vacuum cleaner was purchased to replace the heavily used one that serves the Parish House.
- A lighting system that uses LED rope lights is being installed in the Chapel to illuminate the stained-glass window. An experiment using a flood lightdid not produce a satisfactory result. The lights will be on a timer to be on in the early evenings.
- Also, all of the overhead lights in the Chapel have been replaced as several weren't working and others were not matched up in illumination.

- Our Properties Subcommittee has been looking at installing heating/AC in the Chapel and Meeting House. The results of the research and quotes will be considered at the December Governing Board meeting. (also see Gov Brd minutes)

- After our November communion, Marsha Creese and Jamie Lang-Rodean added to the harvest decorations on the table in the chancel in anticipation of Thanksqiving Sunday, November 21, 2021.
- Deborah Gacek is coordinating poinsettia orders for our Christmas Eve service.
- The Worship Team met on Monday, November 22, 2021. Our main agenda item was to choose the time for the single service on Christmas Eve. The unanimous choice was 5:00 pm.
- Marsha and Jamie put away the autumn decorations after the Worship Team meeting.
- On Saturday, November 26, 2021, Paul and Jamie met with the VIEW
  Team and other volunteers to decorate the Meeting House for Advent and
  Christmas. Many thanks to Erin Scholes, Sue Irvine, Wes Lang-Rodean,
  Anne Usher, Lisa Haupt and Marsha Creese.
- Thanks to Duffy Brookes for purchasing the batteries for our window candles and for always checking the "twinkling lights" strung around the balcony and keeping them in working order.
- Also, many thanks to Marsha Creese for making the wreaths that are hung on the Meeting House front doors and the outside door to the office.
- We removed the curtains from the main floor of the Meeting House since they looked gray in color and were "sticky" to the touch as we found when we removed them. We do not think laundering will help since they are so

old that we suspect the fabric will fall apart. We are not sure how to proceed to purchase new ones. Perhaps a small group could be appointed to investigate this situation. The upstairs curtains remain and are more complicated to hang than the ones in the downstairs. (also see Gov Brd minutes)

 Flowers were given by the church on Sunday, November 27th in memory of our dear Jim Bobbitt.

Summary of Treasurer's Report – October 2021 – provided by Bob Malecki 2021 Budget is running about \$30,000 under budget – similar to last month. Current year pledges are \$431 behind the budget plan, with total contributions \$7,151 ahead of plan. Expenses are about \$24,000 under budget year-to-date, with about \$16,800 of this due to Senior Pastor and Communications & Digital Ministries Specialist expenses being less than planned. We continue to do well financially in 2021.

#### 2021 Investments

Our Morgan Stanley Managed Fund investments are up by 6.8% Jan-Sep 2021. Over the past

five years, our Managed Fund return on investments is 9.25%, which comfortably supports the annual 4-5% distributions from the Housing and Vanderlip Funds to our annual budget, the SCC General Endowment Fund to the Major Project Fund and annual budget, and the Erickson fund to Music Programs and the annual budget.

At the suggestion of the Treasurer, Edwin Whitney Trust Fund Committee made a formal request to the Treasurer and Investment Committee to: "carry out further investigations with an end to potentially securing an investment of our funds wherein they might be moved from the current laddered CDs to a managed, dividend-oriented, higher performing cashgenerating investment. We want to make the most of our funds annually and a higher performing investment could assist us in making even better use and awards from our fund."

On October 8, the Investment Committee met with Ethan Reid, our Morgan Stanley account manager, to define a new investment for the Whitney Trust Fund. The Edwin Whitney Trust Fund Committee subsequently accepted the recommendation of the Investment Committee, and I am working with Ethan Reid to transfer the Whitney Trust Fund investments. I anticipate the new investments will generate >\$1500 annually for scholarships, which is about >\$1000 more than the prior CD investments.

# A Message from the Leadership Discernment Committee...

Greetings friends. The Leadership Discernment Committee has been working to identify nominees for the slate for the annual meeting in January. Thank you to those who have answered our calls and emails and prayerfully considered these opportunities. We have a great church and have been able to fill many of the positions - however there are a few that we are still working on and we wanted to reach out more broadly to make sure that an excellent candidate isn't left out because we didn't think of you!

Treasurer: Responsible for general financial oversight including keeping accounts of all Church fund receipts, disbursements, and balances; paying bills and salaries; managing all non-operating funds and investments; supplying monthly comprehensive financial reports to the Governing Board and monthly reports to the various committees, ministry teams and activities showing the current position of their operating and non-operating budgets, and an annual financial report on all Church funds to the Annual Business Meeting. Many of these responsibilities are delegated to our bookkeeper. The treasurer also works closely with the finance sub-committee of the governing board. This is a two year term and the individual can serve consecutive terms.

Leadership Discernment Committee prepares a slate of nominees for all elective offices to be filled at the Annual Business Meeting. This is a three year term and includes 3 elected members plus the immediate past governing board chair and the current vice-chair.

Clerk: Secretary to the Governing Board and the Church. Responsibilities of the Clerk shall include keeping a faithful record of the proceedings of the meetings of the Church and of the Governing Board, ensuring that accurate records of baptisms and marriages are kept; issuing the call for meetings of the Church; conducting correspondence; and performing such other duties as usually pertain to the office of clerk of an assembly. This is a two year appointment/

Caring Ministries Lead Coordinator - assists the Pastor in arranging Caring activities for members who need transportation, are ill or in the hospital, have lost a loved one or who are going through difficult times. This leader maintains awareness of all the prayer requests and supervises the teams for meals, rides, cards, flowers, prayer shawls, visits and funeral receptions. This

role could be enhanced into a Wellness Ministry and possibly combined with our developing Mental Health Ministry.responsible for vision and leadership of caring ministry areas and for coordination of caring ministry activities with other ministry areas.

# **JUST PEACE PROGRESS**

# CLIMATE CHURCH, CLIMATE WORLD By Rev. Jim Antal

Rev. Jim Antal, is an environmental activist and public theologian. In 2013 he authored a UCC Synod Resolution to divest from fossil fuel companies. In July 2017, Rev. Antal formed a UCC Synod Resolution declaring "a new moral era in opposition to President Trump's withdrawal from the Paris Climate Accord. Since July 2018, Rev. 

Turk, a white supremacist, and Brittany Bauer come to the delivery room for the birth of their baby and demand that Ruth Jefferson, an African American nurse, have no

interaction with their son. Ruth has the choice to heed her humanity and her oath as a nurse to follow orders. She follows her own beliefs but can't prevent serious consequences. She is charged with felony crimes. The story continues as racism shines through aspects of character and plot.

#### What Are Star Words?



The use of star words, also called "star gifts," is a prayer practice connected to Epiphany and the new year that has been growing in popularity in Protestant churches for nearly a decade now. The idea is that a list of intention words, or guiding words, written or printed out and shared for Three Kings Day.

There Are Several Theological Statements Being Made in this Tradition:

- The Magi followed a star, which ultimately led them to Jesus. Therefore, we too use all the resources we have available to us—including creative prayer practices and intention words for the new year—to move closer to Jesus.
- We trust that God uses multiple ways to guide us and speak to us. Star words are one such lens that might provide us a way to look for God in our midst, both actively and in hindsight.
- We trust that it is often easy to miss God in our daily midst. Having an
  intention word to consider both in present days, as well as to reflect on at
  the end of the year, allows for us to see God in ways we may not have seen
  God before. This is the greatest gift.
- We know that the most common prayer practice for many involves speaking to God as opposed to silence or contemplation. We believe that star words invite a new prayer rhythm of reflection and review that can be a powerful new way to connect with God.
- By not looking or sorting through the star words at their selection, we
  practice the spiritual task of receiving. It is not we who are in control in this
  moment. Instead, we trust that God is present, and we let go of our desire
  to cultivate or control.
